· Requirements and information:

- 1. Affidavit with complete names and addresses of both the judgment creditor and judgment debtor.
- Instructions for Service (required to send notice to the judgment debtor of the filing of a judgment against him / her in the Court of Common Pleas).
- 3. Praecipe for Certificate of Judgment.
- 4. Authentication of Judgment signed by the Clerk of Courts, the Judge, and the Clerk of Courts again.
- 5. Filing fee in the amount of \$50.00 made payable to the "Delaware County Clerk of Courts".

Please be sure to include your return and service copies of the above along with a self-addressed stamped envelope. Service will be issued by certified mail unless we are instructed differently by you.

Note: This judgment cannot be accepted for filing unless the above information is completed and submitted in full.

It is very helpful when we process your request if the affidavit or praecipe has all the required information (complete names, addresses and judgment amounts, etc.) on one page, if possible.
